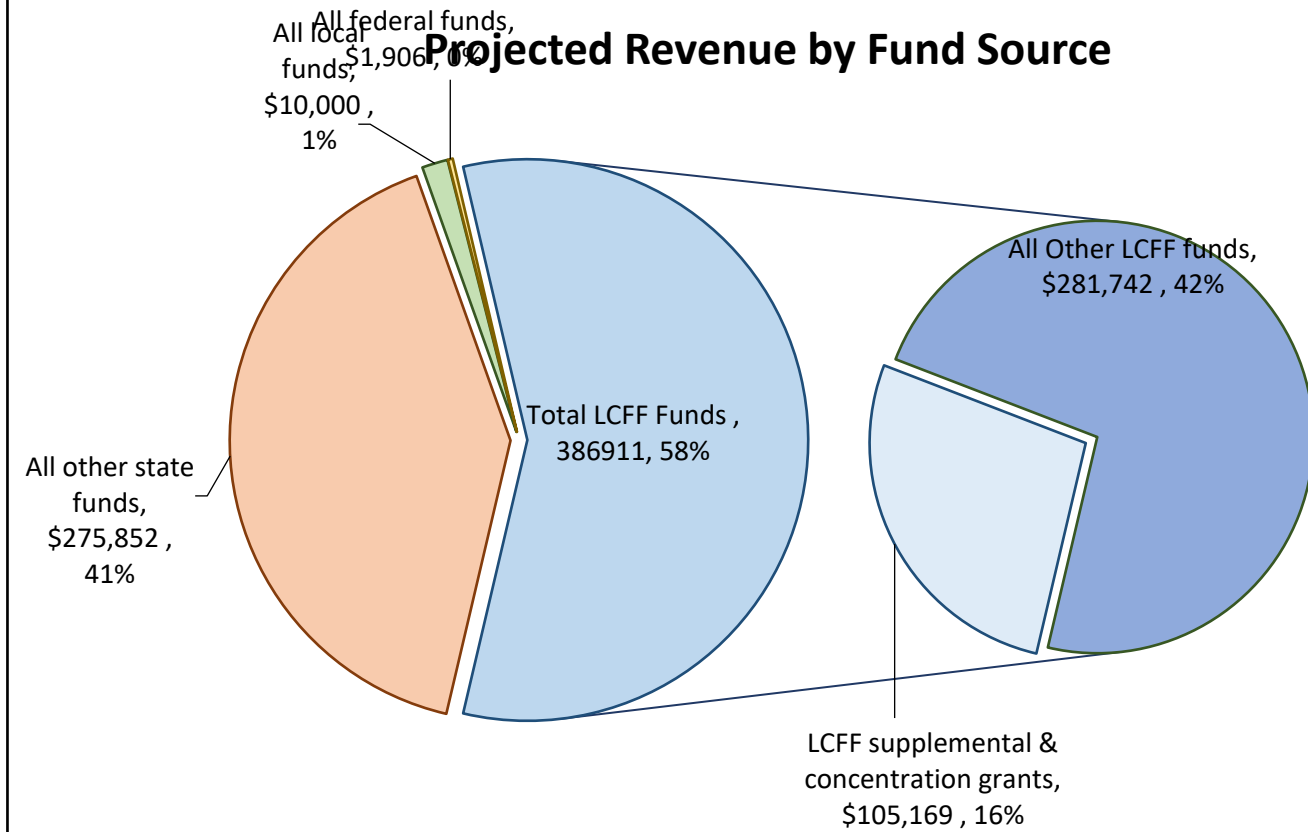

### Projected Revenue by Fund Source

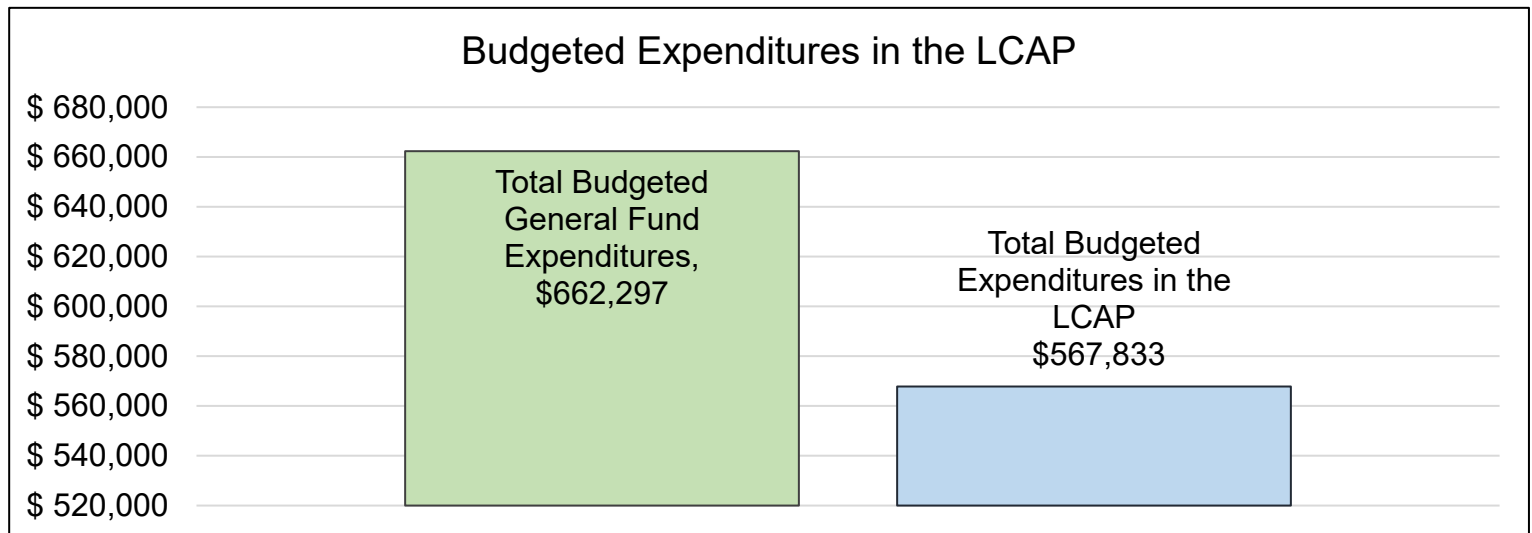


This chart shows the total general purpose revenue Jardin de la Infancia expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Jardin de la Infancia is \$674,669.00, of which \$386,911.00 is Local Control Funding Formula (LCFF), \$275,852.00 is other state funds, \$10,000.00 is local funds, and \$1,906.00 is federal funds. Of the \$386,911.00 in LCFF Funds, \$105,169.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

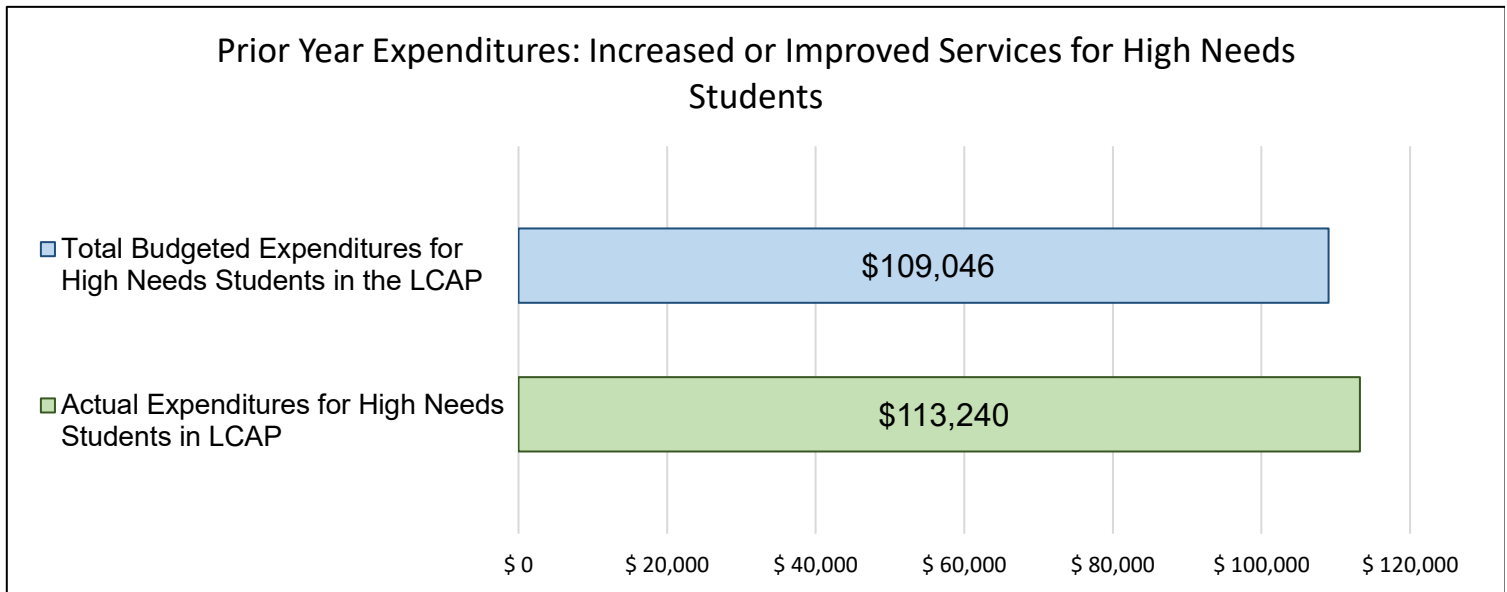

## Plan Summary 2025-2026

### General Information

Jardin de la Infancia is an independent, direct-funded charter school serving students in Transitional Kindergarten through Grade 1. Jardin serves a student population that is 91% Hispanic/Latino, 5% Black/African American, and 5% of mixed race. Of the student population, 55% are classified as English Learners, 14% as Students with Disabilities, and 95% qualify for free or reduced-price meals. Based on these demographics, nearly all students at Jardin are considered Unduplicated Pupils under the Local Control Funding Formula (LCFF) and are included in the LCAP Supplemental and Concentration Funding calculations.

Jardin continues to provide an extended instructional day and an extended academic year to allow for deeper learning and targeted intervention. The school's educational program emphasizes high expectations, strong classroom management, explicit skills instruction, positive reinforcement, and integrated, cross-curricular learning. This approach is designed to support both academic growth and social-emotional development in a safe, inclusive, and nurturing environment.

### Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Jardin de la Infancia continues to maintain a strong track record in supporting student well-being and behavior. As of the most recent data, our Suspension/ Expulsion Rate and Chronic Absenteeism remains at 0%. This ongoing success reflects our commitment to a proactive and supportive school culture. We will continue to build on this foundation through implementation of our Social Emotional Learning program and The Incredible Years Character Education curriculum, which has proven to be effective in promoting self-regulation, empathy, and positive peer interactions.

This year marked our first full year of implementing the i-Ready diagnostic assessment in both English Language Arts and Mathematics. Unlike the prior year, where our baseline assessment began mid-year, this year we were able to track student growth across three diagnostic windows. The results show promising progress:

- 70% of students met or exceeded typical growth targets in Reading
- 53% of students met or exceeded typical growth targets in Math

These results demonstrate that students are making meaningful academic gains, particularly in foundational literacy skills. The use of the MyPath individualized learning platform allowed teachers to target instruction more effectively based on diagnostic results.

Moving forward, Jardin will continue using i-Ready and MyPath in the 2025–26 school year, with an increased focus on small-group instruction and intervention support to ensure that all students—especially English Learners and students with disabilities—are on track to meet grade-level expectations.

### A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Feedback from our educational partners played a critical role in shaping the 2025–26 LCAP, ensuring it reflects the evolving needs and priorities of our school community. Parents emphasized the continued importance of a safe, welcoming, and engaging learning environment. In response, the LCAP includes actions to enhance campus safety and cleanliness, as well as initiatives to increase family engagement and improve two-way communication. Families also highlighted a need for greater support in helping English Learners at home, which informed the inclusion of additional resources and strategies focused on English Language Development (ELD) both in school and for at-home reinforcement.

Teachers shared valuable insights into instructional effectiveness, curriculum alignment, and areas for professional growth. Their input directly influenced the inclusion of targeted professional development opportunities, particularly around identifying and addressing learning gaps. Teachers also advocated for sustained small-group instruction and differentiated learning—leading to specific actions that support these strategies across all grade levels, with an emphasis on meeting the needs of students who require additional academic or behavioral support.

The School Director focused on aligning resources with high-impact practices to maximize student outcomes. This feedback led to the strategic prioritization of funding for intervention programs, services for students with disabilities, and tools that support data-driven instruction. The LCAP reflects a commitment to using multiple measures of student data to guide instructional planning and monitor progress toward academic goals.

The Governing Board reinforced the importance of transparency, fiscal accountability, and ongoing progress monitoring. In response, the LCAP includes clearly defined metrics and a commitment to regular reporting on implementation and outcomes.

Los Angeles County Charter SELPA engaged in a review and discussion of the plan's goals and actions, providing specialized input to ensure alignment with supports for students with disabilities.

Overall, this collaborative engagement process has led to an LCAP that is both responsive and strategic—grounded in the perspectives of our educational partners and aligned to the shared vision for student success at Jardin de la Infancia.

- Data-driven instruction has been effective, with teachers using assessment data to guide instruction and monitor student progress.
- Differentiated support has led to gains for ELs—evidenced by a 73% show annual progress on ELPAC—and some improvement for students with disabilities, though this remains a focus area.
- Small class sizes have allowed for more targeted instruction and stronger student-teacher relationships.
- Extended school day and year have benefited low-income students, foster youth, and ELs by providing additional time for learning and support.

- If “Yes” is entered into the Contributing column, then complete the following columns:
  - **Scope:** The scope of an action may be LEA-wide (i.e., districtwide, countywide, or charterwide), schoolwide, or limited. An action that is LEA-wide in scope upgrades the entire educational program of the LEA. An action that is schoolwide in scope upgrades the entire educational program of a single school. The LEA reviews the original estimated cost for the action and determines that had it hired additional staff to collect and analyze data and to coordinate supports for students that estimated actual cost would have been \$169,500 due to a cost of living adjustment.   - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.
